





### FINANCIAL REPORT TO THE PARISH

### (Fiscal Year 7/1/21 - 6/30/22)

Fiscal 2021-22 was certainly full of suspense and surprises. The church HVAC split system failed in July and both Parish Hall package units failed in December. The required bidding process and funding requirements, coupled with COVID related supply chain issues, were difficult challenges for all of us. We had to deal with heat throughout the summer and cold throughout the winter. Although we still had heat in the church, the blower system failed and required emergency repairs until the new system was installed. We are grateful for the support, cooperation, and indulgence of parishioners during the many months of discomfort. With the approval of the Archdiocese, we were able to start the HVAC fund campaign in September. Thanks to you, the HVAC campaign was a remarkable success, without a diocesan loan, and concluded within a year! *[Replacement package units for the church narthex and choir loft are on order and scheduled for installation in early January 2023.]* We still have a minor issue with the church HVAC (ductwork rattle) which our contractor, Tebarco, is working to resolve. We have withheld \$10,000 until the issue corrected.

During mid-fiscal 2022 we transferred accounting services to Shared Accounting Services (SAS) which is operated by the Archdioc ese to support smaller parishes with <u>free</u> accounting services. Although mid-year transition was difficult, we are grateful for this additional assistance. The federal Payroll Protection Plan (PPP) provided us with \$27,223 during the pandemic. We did not have a Fall Festival but had a raffle at Christmas which raised \$4,252. We had a successful Cinco de Mayo event (\$12,097). We had a successful 2021 Annual Appeal which exceeded the goal (\$34,200), resulting in an initial rebate to the parish of \$8,550 and the balance deposited to our endowment account maintained by Catholic Foundation of North Georgia (\$5,065), pursuant to new Archdiocesan guidelines. *[We recently received an additional refund of \$3,058 for donations made after appeal contributions were reconciled].* 

Other accomplishments during the fiscal year:

- Consolidated fiber optic Wi-Fi services and switched to VOIP phone technology
- Conducted a parish survey and are now analyzing data
- Installed a backup generator at the rectory
- Implemented a new email system with administrative controls
- Major funding challenges on the horizon include:
- Connection of septic systems at the church and parish hall to the city system
- Replacement of signage and flagpoles at the intersection
- Lighting issues with the aging church light system controls
- Church and rectory roof replacements (sooner) and education building (later)
- Completion of the OLG basement for educational and conference purposes
- Potential repairs due to damages from vibration during DOT bypass construction
